APPLICATIONS

WARNING TO USER

DO NOT USE AGAINST:

- 1. Concentrations of contaminants which are unknown, or are immediately dangerous to life or health.
- 2. Concentrations of particulates which exceed the maximum use concentration or 10 times the OSHA Permissible Exposure Limit, whichever is lower.
- 3. Gases, vapors, asbestos, paint spray, sandblasting or particulate materials which generate harmful vapors. This respirator is not approved for any vapors or gases, so when used against organic vapor odors and/or ozone do not exceed the OSHA Permissible Exposure Limit.
- 4. Oil-based mists.

RESTRICTIONS:

- 1. This respirator does not supply oxygen and must not be used in atmospheres containing less than 19.5% oxygen.
